Mr. Fakhri is a person who takes responsibility for voicing the trade union's message to all the workers and employees and undertaking the task of coordinating with the trade union committees representatives, and members of the administrative body; overseeing the effective functioning of the union, training; solving challenges and providing timely responses to requests for information; taking charge of the administration of collective bargaining agreements; ensuring all activities comply with applicable state and keeping track of current trends in labor laws, and employment.

health care costs, pensions, and other benefits.

- Representing trade union members in disciplinary hearings when they are accused of violating union rules
- Monitoring workplace conditions such as employee safety, discrimination, or sexual harassment to ensure that employers are in compliance with laws.
- Maintaining membership records for members who have joined the union

Mr. Fakhri as a social activist participated in several campaigns related to combating drug use among youth, improving children's cognitive capacity at public schools, and preventing and stopping the culture of celebrating with firearms. All these campaigns took place in the Naour municipality where he was born.

In addition to participating in many pressure campaigns led by trade unions to amend the Jordanian Labor Law and the Social Security Law.

He is a founding member of "The campaign on violence and sexual harassment in the workplace in Jordan" which was implemented by ActionAid Arab region from 2019 till May 2022.

Mr. Fakhri participated in several workshops and activities related to social dialogue with SOLiD project of the Arab Federation of Trade Unions (ATUC). Mr. Fakhry is an expert in social dialogue.
